 - 1. Addressed EGSC recommendations:
 - a. Removed redundancies and contradictions
- b. Consolidated information about EGSA practices and procedures from Bylaws into Constitution
- c. Moved information about external obligations and communications procedures to Bylaws
 - 2. Overhauled voting procedures; two types of votes:
 - a. Electronic votes of the entire membership for issues such as Presidential elections, Budget, Impeachment, Constitution Ratification
 - b. In-person hand votes at EGSA meetings for other issues
 - 3. Updated Committee responsibilities
 - a. Craft Fair Committee renamed Fundraising Committee to accommodate possible additional fundraising events
 - b. Recruiting Committee renamed Hospitality Committee and expanded its role to host the recruiting events and the Welcome Back Picnic.
 - c. Eliminated Seminar Committee as this role is redundant with that of the Representative(s) to the Department's Seminar Committee



Created Annual Committees (Budget Committee, Constitution & Bylaws Committee)


- e. Constitution & Bylaws Committee shall meet at least once a year to review Bylaws, every three years to review Constitution. Shall coordinate proposed amendments
- 4. Clarified the role of representatives
 - a. EGSA sends representatives to both GSA and departmental commmittees. We clarified the nature of these positions in the Bylaws and specified that all representatives should be listed on the website.
- 5. Added responsibilities for administering awards
 - a. The President is responsible for awarding the annual EGSA Faculty and Staff Awards, based on polling the membership (as currently practiced by not previously written down)
 - b. The Vice President is responsible for nominating students for appropriate external awards, such as the ESA Pac Branch Student Leadership Award (as was done in 2012 but not since)

Voting to approve the new constitution will occur in two weeks

NEW BUSINESS:

- 1. Undergraduate and Graduate Boards update (Debbie De La Riva, John Hash, Austin Baker) should be done by February 28
- 2. Reward 4 Riverside STEM Academy middle school students who really know their insects! Would EGSA be willing to donate case to give these hard-working students some UCR/Entomology t-shirts, posters, etc.? (Sarah O'Neill) Unanimous vote (19) to donate both t-shirts and posters
